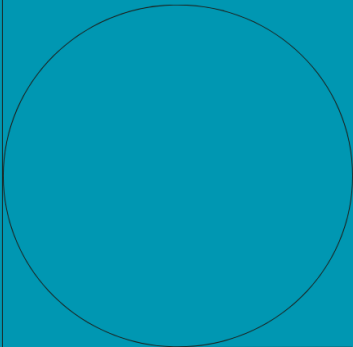


# An Eggceptional Match: Egg Donor Fee Estimate



<b><i>Consult</i></b>	A thirty-minute consultation shall be provided to discuss our process, associated costs, and related matters.	<b>No Charge</b>
<b><i>Agency Retainer</i></b> <i>Fee is separate from escrow and is non-refundable</i>	The agency will initiate contact with the donor to commence coordination and will transfer the donor’s profile and all applicable medical records to the clinic. Retained services shall be provided for a duration of twelve months.	<b>\$500.00</b>
<b><i>AMH</i></b> <b><i>Optional Add On</i></b>	Testing provided through an outside Laboratory <i>** Includes small processing fee charged to An Eggceptional Match for purchase**</i>	<b>\$150.00</b>
<b><i>Agency Fee</i></b> <i>Fee is non-refundable, re- matching services offered for 12 months from execution of contract</i>	The agency will coordinate the donor’s medical and psychological testing with the Intended Parent(s)’ clinic, follow up on results, manage travel and cycle logistics, and oversee the legal contract process.	<b>\$10,000.00</b>
<b><i>Family Limit Compliance Fee</i></b>	<p>This fee covers the administrative work necessary to ensure compliance with Colorado’s Donor-Conceived Persons Protection Act (DCPA), specifically the family-limit regulations. Services include:</p> <ul style="list-style-type: none"><li>- Verifying donor eligibility for additional retrieval cycles or sibling projects.</li><li>- Tracking and documenting all family matches to ensure adherence to the 25-family cap.</li><li>- Coordinating with clinics and legal teams to secure appropriate donor consent and manage any applicable exceptions.</li><li>- Conducting biannual follow-ups with recipient families to obtain pregnancy and live birth outcomes.</li><li>- Conducting annual follow-ups to ensure the donor’s demographic, medical, and family medical history remain current.</li><li>- Maintaining permanent records as required under the DCPA.</li></ul>	<b>\$400.00</b>
<b><i>Escrow</i></b> <i>Fee is paid to AEM and SeedTrust escrow</i>	The agency will assist with the establishment of the third-party escrow account and will promptly handle all reimbursements through this account. Additionally, detailed travel expense breakdowns will be provided as necessary to ensure transparency and proper documentation.	<b>\$800.00</b>
<b><i>Egg Donor Compensation</i></b>	<p>The agency provides guidance to donors based on industry-standard recommendations; however, each donor retains the right to set their desired compensation. Previous donors may request an increase in compensation.</p> <p>Donor compensation does not include reimbursement for missed wages, travel expenses, communication costs, gasoline, or childcare.</p>	<b>\$8,000.00</b>
<b><i>Psychological Evaluation</i></b>	Psychological Evaluation along with a Personality Assessment Inventory <i>* If applicable, fees may vary by state</i>	<b>\$500.00</b>
<b><i>Oocyte Donation Agreement</i></b>	<p>Your Oocyte Donation Agreement (ODA) will be prepared by one of our referred attorneys on your behalf. Your donor will have separate representation from a different firm so no conflict of interest will be of concern. If you have an attorney you would like to utilize who specializes in Reproductive Law, please let us know immediately.</p> <p><i>*Subject to change based on attorney choice and location</i></p>	<b>\$2,500.00</b>

<b><i>Travel Expenses</i></b>	Intended Parents are responsible for donor and companion airfare, ground transportation, gratuities, parking, tolls, lodging, communication expenses, and a food per diem as outlined in the ODA. Travel locations may affect these fees; estimates are based on typical travel requirements, but actual costs may vary depending on destination, duration, and travel arrangements.	<b>\$6,500.00+</b>
<b><i>Outside Monitoring</i></b>	Agency will obtain quote from a local fertility clinic for your budgeting purposes. Clinic fees will be paid by Intended Parent’s credit card on file with AEM.	<b>Up to \$3,500.00</b>
<b><i>Video Conference</i></b>	Coordination of video conference conducted between the Intended Parent(s) and the Donor.	<b>\$250.00</b>
<b><i>Egg Donor Hold</i></b>	Payable to An Eggceptional Match should you place your journey on hold.	<b>\$250.00</b>
<b><i>Clinical and Pharmaceutical Fees</i></b>	Clinical and pharmaceutical fees are NOT included within your escrow account.  All medical and pharmaceutical expenses incurred are the responsibility of the Intended Parent(s) and paid to the provider directly. Please contact your clinical team for an estimate.	<b>Variable</b>
<b><i>Affiliate Agency Fee</i></b>	An Eggceptional Match has access to over 6,000 additional donors through our “Affiliate Agency Network”. Should you have interest in one of these egg donors, additional fees will be incurred, collected and paid from your established escrow account directly to the affiliate agency on your behalf.	<b>\$1,500.00- \$5,000.00</b>
<b><i>International Agency Fee</i></b> <i>Fee is non-refundable</i>	Where applicable to cover translation fees for cycle.	<b>\$5,000.00</b>
<b><i>Notary Fees</i></b>	Includes notarization of the donor’s DCPA consents and Oocyte Donation Agreement. Additional notary services, if required, may incur a separate fee.	<b>\$100.00</b>
